#### APPLICATION - ALWAYS WEAR SUITABLE PPE

- SHAKE THE CONTAINER FOR 30 SECONDS BEFORE EACH USE
- Brush away leaves and debris before applying
- Do not apply if rain is expected within 4 hours
- Add 1 measure (100ml) to 5 litres of clean water and mix thoroughly
- Apply using a spray, watering can or brush, at a coverage rate of:  
Dilute 1 dose (100ml) for light contamination in 5 litres water  
Dilute 2 to 3 doses for heavy contamination in 5 litres water
- Ensure heavy growth areas are saturated
- Repeat application if problem persists

#### Precautions

- **Always test a small inconspicuous area before use to ensure surface compatibility, performance and finish is acceptable**
- Protect any surface or area not being treated
- May be corrosive to metals
- Keep away from plants
- Never mix or add any other cleaners or acid to the product
- Keep away animals and pets until cleaning process is complete and surface is dry
- For use only as a surface biocide
- Surface biocide for amateur and professional use against algae
- Causes skin irritation and serious eye damage
- Harmful if swallowed
- Very toxic to aquatic life

- Wash hands thoroughly after handling
- Use only outdoors or in a well-ventilated area
- Do not breathe vapour

#### Storage

- Store between 5°C and 25°C and keep container tightly closed
- Keep out of direct sunlight and protect from frost
- Keep out of reach of children

#### Health & Safety

- Contains Benzalkonium Chloride
- Approved HSE BIOCIDE LICENCE
- **IF ON SKIN:** Gently wash with plenty of soap and water. Take off contaminated clothing and wash before reuse. If skin irritation or rash occurs seek medical advice/attention
- **IF IN EYES:** Bathe the eye with running water for 15 minutes. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention. Remove contact lenses if possible and safe to do so
- **IF SWALLOWED:** Rinse mouth. Do NOT induce vomiting. Wash out mouth with water. If conscious, give half a litre of water to drink immediately. Transfer to hospital as soon as possible
- **IF INHALED:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If feeling unwell, call for medical assistance
- Dispose of in accordance with national/local regulations
- Do not discharge into drains or rivers
- Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method
