EASYCare Salt Remover is a professional grade product that is a fast and effective way of removing unsightly blooms of efflorescence from newly laid brickwork and concrete pavers.

Features & Benefits

- Ready-to use formula-no mixing or diluting required
- Fast and effective

- Easy to use-simply add to low pressure sprayer and apply

APPLICATION TYPES DEPENDING ON USAGE: SHAKE WELL FOR 30 SECONDS BEFORE USE.

ON WALLS: Apply using a spray or brush, to a dry surface at a rate of 4 - 5m² per litre of product.

ON PAVED AREAS: Apply using a spray, watering can with fine rose attachment or brush, to a dry surface at a rate of 4 - 5m² per litre of product.

- Ensure heavily contaminated areas are saturated with product.
- Leave for 1 hour and re-apply. Leave for up to 24 hours for effective removal of salts.
- Wash surface salts away with a dilution of 1:50 salt remover to water with a stiff brush or power jet and leave to dry. Once dry the surface can be treated with one of our sealers.

Coverage

- Up to 15m² depending on porosity of surface

Precautions

ALWAYS TEST A SMALL HIDDEN AREA BEFORE USE TO ENSURE FINISHED RESULT IS ACCEPTABLE.

Keep children and pets away until the surface is completely dry.
Ideal operating temperature between 10°C and 20°C.
DO NOT DILUTE.

Do not apply in damp/wet conditions.

Do not apply during frost or when temperature is below 5°C.

Do not use on aluminium or marking may occur.

Keep away from shrubs, grass and plants.

Cleaning of Equipment

Remove as much excess product as possible and clean tools and equipment immediately after use with soapy water.

Storage

Keep in a cool, dry place between 5°C and 30°C in the original container with lid tightly closed.

Health & Safety

Causes skin irritation. Causes serious eye irritation.

Keep out of reach of children.

Do not get in eyes, on skin, or on clothing. Wash hands thoroughly after handling. Wear protective gloves/protective clothing/eye protection/face protection.
